Energex – June-Dec 2024 – Energex Room Access

Energex require access to TQ lease area to access Energex rooms and Energex infrastructure that may be located on Transurban Assets. This access is to facilitate corrective maintenance, repairs as required to Energex infrastructure only, where Energex works may impact power supply to Transurban Assets – Energex will advise Transurban of any operational impacts.
