Approval Permit for Temporary Partial Road Closures on Council Controlled Roads

Applicant: Energex and its approved agents

Location: Council controlled UBD Yellow and White Roads

Type of Closure: Verge / Parking Lane / Lane / Half Road Closures only

Reason for closure: Energex Works

Work Type: Short term, low impact

Start Date: 01/07/2024 **Finish Date**: 30/06/2025

This permit is issued as an approval for temporary partial road closures only, <u>full closures</u> <u>are not</u> to be carried out under this permit.

This permit is issued subject to the following conditions:-

- All works are to be carried out in accordance with the Manual of Uniform Traffic Control Devices (MUTCD) Part 3: Works on Roads.
- A traffic management plan for the work zone should be prepared in accordance with the Manual of Uniform Traffic Control Devices Part 3.
- A copy of this permit and the Traffic Management Plan is to be held by the Traffic Controller/s undertaking traffic control for the duration of works.
- This permit does not include approval to close bus stops, disabled parking, clearways or for any excavations carried out within the roadway.
- Works carried out on UBD White Roads are to be undertaken between 6.00am and 6.00pm on weekdays.
- Works carried out on UBD <u>Yellow Roads</u> are to be undertaken outside peak traffic periods only, being between 9.00am and 4.00pm on weekdays.
- Weekend works will require notice to Council two (2) working days prior and shall be undertaken between 7.00am and 5.00pm.
- No works on public holidays is permitted.
- Works within 100 metres of a school zone are to be limited to the hours between 9.00am and 2.00pm on school days.
- Traffic control personnel are to ensure disruption to local traffic is kept to a minimum
 and access to driveways is maintained at all times. In the event the traffic delays
 are excessive or too disruptive, Council may withdraw the permit and reissue at a
 more suitable time.

- Existing pedestrian access must be maintained at all times. If access cannot be maintained, appropriate alternative provisions and signage must be erected.
- A separate application must be submitted for major projects (non-maintenance works exceeding one day), works near signalized intersections which may impact on traffic signal operations, or for any night works.
- All emergency service authorities in the area must be notified of the works prior to the partial road closure occurring.
- A copy of permits from the Queensland Police Service and any other relevant road authority must be obtained prior to works commencing and be available on site at all times.
- Local residents, businesses, bus and taxi companies directly affected are to be advised through public notices, media or letterbox notices prior to the temporary road or verge closure.
- Following the completion of the works, the road and road verge is to be returned to the condition similar to that prior to the closure. All rubbish, debris and equipment is to be removed from the work zone prior to the road being returned to normal traffic flow.
- Due to the various locations associated with this permit, Energex may find the
 proposed work area is already occupied by other approved works. If this is the case
 Energex is not to occupy any of these areas without the express consent of Council.
 This permit does not give priority to Energex over work areas.
- This permit is only transferable to current Energex sub-contractors as specified in Energex Service Provider arrangements for maintenance activities on Energex electrical infrastructure/network.
- Non-compliance with the conditions outlined above may result in the permit being suspended or revoked. Ongoing monitoring of compliance with the Traffic Management Plan may be conducted by an appointed City of Moreton Bay officer.
- Energex agrees to indemnify and keep indemnified the Council against all liability for death of or injury to persons or loss of or damage to property and all actions, claims, demands, losses, damages, costs and expenses whatsoever the Council, its officers, employees, agents and contractors may suffer or incur in relation to any actions or works undertaken by Energex, its employees, agents and contractors in relation to this permit.
