**CONDITIONS**

1. THIS PERMIT SHALL REMAIN IN FORCE UNLESS SOONER SUSPENDED, SURRENDERED, OR CANCELLED.
2. ALL SIGNS, LIGHTS AND SAFETY CONES SHALL COMPLY WITH, AND BE POSITIONED/ERECTED AS PER THE MANUAL OF UNIFORM TRAFFIC CONTROL DEVICES PART 3 AND QLD GUIDE TO TEMPORARY TRAFFIC MANAGEMENT.
3. ACCREDITED TRAFFIC CONTROLLERS SHALL OPERATE IN ACCORDANCE WITH THE TRAFFIC CONTROLLER ACCREDITATION SCHEME – APPROVED PROCEDURE.
4. ACCESS TO AND FROM BUSINESS/RESIDENTIAL PREMISES TO BE MAINTAINED AT ALL TIMES UNLESS PRIOR ARRANGEMENTS WITH THE OCCUPIER.
5. ALL PRECAUTIONS TO BE TAKEN TO AVOID INCIDENTS.
6. PERMIT TO BE HELD ON SITE AT ALL TIMES AND PRODUCED UPON REQUIREMENT BY AN AUTHORISED OFFICER.
7. AREA TO BE DEFINED TO PREVENT PEDESTRIAN ACCESS THROUGH WORKZONE.
8. PERMIT IS FOR MINOR WORKS (as detailed above) on BCC ROADS AS DEFINED IN THE UBD STREET DIRECTORY ONLY. NO CLOSURES PERMITTED TMR CONTROLLED ROADS. NO FULL ROAD CLOSURES PERMITTED.
9. MINOR WORKS ON ROADS AS DEFINED IN THE UBD STREET DIRECTORY: WHITE ROADS (ALL CLOSURE TYPES EXCEPT FULL ROAD CLOSURES) BTW 6.00AM – 6.00PM & 6.00PM – 6.00AM. YELLOW ROADS (PARKING LANE/SHOULDER/PARTIAL LANE IN A SINGLE DIRECTION/CONTRA-FLOW PROVIDED THE EXISTING TRAFFIC LANE CAPACITY IS MAINTAINED, HOLD & RELEASE) BTW 9.00AM – 4.00PM WEEKDAYS, 5.00AM – 8.00PM WEEKENDS & 8.00PM – 5.00AM. ALL CLOSURES WITHIN SCHOOL ZONES RESTRICTED 9.00AM – 2.00PM ON SCHOOL DAYS.
10. WHERE STOP/HOLD & RELEASE IN PLACE SUCH CLOSURE TO BE KEPT TO A MINIMUM WITH REOPENING OF THROUGH TRAFFIC AS SOON AS PRACTICABLE BUT NO MORE THAN TWO MINUTES; STOP/HOLD IS NOT TO CAUSE TRAFFIC CONGESTION AND IS TO BE TIMED TO MINIMISE TRAFFIC BUILDUP.
11. APPLICANT SHALL IMMEDIATELY OBEY ANY LAWFUL DIRECTION GIVEN BY POLICE.
12. PERMIT NOT VALID IN DISABLED PARKING ZONES, CLEARWAYS, BUS STOPS, ACCESS TO PROPERTIES, WORKS I/V SCHOOL ZONES WITH SCHOOL SPEED RESTRICTED ZONES DURING THE IMPLEMENTATION TIMES, WITHIN 1KM RADIUS OF RNA SHOWGROUNDS DURING EVENTS & ON EVENT DAYS/NIGHTS SUNCORP TRAFFIC AREA. NO CLOSURES PERMITTED DURING PLANNED MAJOR EVENTS. NO CLOSURES PERMITTED BRISBANE CBD & FORTITUDE VALLEY AREAS.
13. PERMIT NOT VALID WHERE OTHER ROAD/LANE CLOSURE APPROVALS HAVE BEEN GRANTED AND IS NOT TO INTERFERE WITH OTHER WORKS IN PLACE.

<ul style="list-style-type: none"><li>• Random audits of compliance with permit conditions will be conducted.</li><li>• Permit holders failing to comply with permit conditions will be breached.</li><li>• Subject to the type of non-compliance, the permit may be cancelled in which case the permit holder will be required to cease work.</li><li>• If the permit relates to road works or lane/footpath closures, the permit holder will be required to render the site safe before leaving the site.</li><li>• The permit holder will be liable for cost recovery if a police presence is required during render safe procedures.</li></ul>

14. TWO WAY TRAFFIC TO BE MAINTAINED WHERE POSSIBLE.
15. ACCESS TO BUS STOPS & SERVICES TO BE MAINTAINED UNTIL END OF LAST SERVICE.
16. CLOSURE NOT PERMITTED ON CONNECTING ROADS WITHIN THE DISTRICT DURING PEAK HOURS 7.00AM – 9.00AM & 3.00PM – 7.00PM.
17. DEDICATED PARKING LANES PERMITTED TO BE CLOSED ANY TIME WHERE CURRENT LANE CAPACITY IS NOT IMPACTED.
18. SEPARATE PERMIT TO BE OBTAINED WORKS BEING PERFORMED AT TRAFFIC CONTROL LIGHTS WHERE THERE IS INTERFERENCE WITH SIGNALS OR NEED FOR POLICE TRAFFIC CONTROL.
19. WHERE TRAFFIC & PEDESTRIAN CONTROL REQUIRED ACCREDITED TRAFFIC CONTROLLERS AND ARROWBOARD VEHICLES TO BE ON SITE TO PERFORM THAT FUNCTION.
20. WHERE ACCREDITED TRAFFIC CONTROLLERS DO NOT HAVE THE AUTHORITY TO PERFORM TRAFFIC CONTROL SEPERATE POLICE PERMIT MUST BE OBTAINED.
21. ROAD TO BE LEFT IN SERVICEABLE CONDITION FREE OF ANY OBSTRUCTIONS AFTER WORKS.
22. A SAFE ROUTE TO BE PROVIDED FOR PEDESTRIANS.
