07:00am - 05:00pm - Saturday and Sunday (only as necessary)**

**No work to be completed on Public Holidays (Emergency Works only)**

Permit shall remain in force from 01/02/2025 to 31/07/2025, unless sooner suspended, surrendered or cancelled.

#### CONDITIONS

- 1. THIS PERMIT IS NOT VALID UNTIL A SIGNED COPY IS RECEIVED BY BEAUDESERT POLICE by email: [Beaudesert.Station@police.qld.gov.au](mailto:Beaudesert.Station@police.qld.gov.au)**
- 2. Official Traffic Signs - i.e. "Roadworks Ahead", "Half Road Closed", "Prepare to Stop" to be positioned at the approaches to the work area.**
- 3. Witches hats to be positioned around the work area.**
- 4. Delineator line of witches hats to be positioned so as to divert traffic into one correct section of the roadway as necessary**
- 5. All signs, lights and safety cones to be positioned and erected as per the Queensland and Austroads Guide to Temporary Traffic Management.**
- 6. All signs, lights and safety cones shall comply with the Manual of Uniform Traffic Control Devices - Part 3.**
- 7. Applicant to ensure that all conditions stipulated by the Scenic Rim Regional Council - RCU24/0509 shall be strictly adhered to.**


8. All signs and other materials to be removed from the roadway and road left in good order and serviceable condition.
9. All precautions to be taken to avoid incidents.
10. Authorised traffic controllers to be utilised to control the flow of traffic passing through work construction area.
11. This permit may be cancelled at any time by any Police Officer.
12. This permit is to be held on site and produced upon demand by any Police Officer.
13. Partial road closures within Scenic Rim Regional Council (excludes Full Road Closures - separate applications are to be made)
14. Any closures on State Controlled/TMR are excluded - approval to be obtained from TMR.
15. As outlined in TMP:
  - 15.1 Emergency Services Access will not be affected by the implementation of any of the TGS
  - 15.2 Local access is maintained, unless Energex have made arrangements with local residents and businesses.
16. This permit does not allow for the partial or full closure of roads in business or industrial areas.
17. No closure shall have significant adverse impact upon any state or federal roads, nor roads in business or industrial areas.


