CONDITIONS

- 1. Permit is in effect for single day uses within the timeframe provided.
- 2. Road closure shall be between the hours of 06:00am 06:00pm weekdays
- 3. Road closure shall be between the hours of 07:00am 05:00pm weekends
- 4. If within 100m of a school zone: road closure shall be between 09:00am 02.00pm on school days.
- 5. Road closures shall not occur in the designated times or areas of any special events that are granted permits by the Sunshine Coast Council or the QPS
- 6. Installation of cones/bollards/signage situated around traffic detours to ensure safety
- 7. Installation of reduced speed signs within the designed work zone
- 8. Any conflicting signs are to be removed or covered during the work period
- 9. Does not supercede any other OPS permits that may have been or are vet to be issued.
- 10. Does not include any full road closures or intersections
- 11. Vehicles and equipment to be escorted into the closure under Traffic Controller supervision
- 12. Necessary access to effected residential and commercial addresses to be maintained within reason and any vehicle access to be under Traffic Contoller supervision
- 13. Pedestrian/Cyclists are to be safely moved around closure under Traffic Controller supervision.
- 14. Take care to avoid incidents, dangerous situations and obstruction to pedestrians and vehicles
- 15. Road detours and signage to be implemented
- 16. Facilitate the prioroty movement of emergency vehicles through the permit area.
- 17. Note this permit is issued by Maroochydore Station and therefore approval should also be sought from the respective OIC of the policing division where works are intended to be conducted.
- 18. Comply with all QGTTM and AGTTM practices.
- 19. This permit is to be held by the site manager at all times and produced upon request by a Police Officer or other relevant authority
