CONDITIONS

- 1. This permit is to be held on site at all times and produced on demand by a Police Officer.
2. All signs lights and safety cones to comple with and to positioned and erected as per the Manual of Uniform Traffic Control Devices.
3. The Applicant is responsbile for ensuring that any excavations, roadworks, barriers, signs materials or objects of any nature associated with the project development are sufficiently lit or made obvious to any pedestrians or motorists so as to prevent risk of injury of death th any person.
4. Safety cones and/or barricading is to be positioned around work sites.
5. Pedestrian access is to be restricted from work sites at all times.
6. Djuring the hours of darkness, barricading shall be positioned around work areas with sufficient flashing amber lights at regular intervals to give adequate warning to pedestrian and vehicular traffic to prevent collision with barricading or excavation materials or trenches.
7. All Signs and materials to be removed from roadway and left in good condition at the completion of works.
8. All Council and/or Main Road Department conditions to be complied with.
9. Alternative safe passage to be made for pedestrians and motorists.
10. Enter and egress are to be maintained for residential and Business AT ALL TIMES.
11. Minimum of One (1) Qualified Traffic Controller and one (1) Traffic Control Vehicle to be on duty during the hours of each site operation to assist motorists and pedestrians around work site as required.
12. All care to be taken to avoid incidents.
13. Access to be available to emergency vehicles at all times.
14. The authority applies to MINOR WORKS ONLY.

This permit does not exempt the holder thereof from obtaining any Permit or other authority under and/or otherwise complying with the provisions of any other law.




